**Subject: Completion of pending IAY houses and Closure of IAY scheme
regarding:**

Sir/Madam,

Please refer to this Ministry's letter of even no. Dated 20.08.2018 on the subject cited above. I am directed to say that in order to ensure seamless closure of IAY scheme the Ministry had requested the States / UTs to complete the incomplete IAY houses by 31st March, 2018. However, it was observed that many States/UTs could not complete the incomplete IAY houses within the given deadline.

2. Accordingly, a meeting to assess the progress on closure of IAY houses was held under the chairmanship of Secretary, Ministry of Rural Development, Govt of India on 26th July, 2018. Minutes of the meeting has already been shared with States/UTs vide letter of even no. dated 20.08.2018. In this meeting it was decided that the Central share required for completion of IAY houses, which were incomplete as on 1st April, 2018, will be released to States/UTs on reimbursement mode, i.e. after completion of IAY houses from State funds.

3. As proposed the said decision, the States were requested to complete the pending IAY houses from States' financial funds on priority and post-completion, claim reimbursement from MoRD. In order to provide further clarity on the reimbursement claim, the States are requested to note the following points:

- States/UTs should ascertain the number of IAY houses that can be completed, funds required for the same and availability of IAY funds. Once intimated to the Ministry, the AwaasSoft portal shall enable generation of Fund Transfer Orders (FTOs) for incomplete IAY houses upto the limit of IAY funds available with the States / UTs. If IAY funds available with the State / UT are

not sufficient to complete the incomplete IAY houses, then the States/UTs will put the required amount (centre + state share) in the State Nodal Account from the State / UT's resources and complete the IAY houses on priority. To enable generation of FTOs for payments against these incomplete IAY houses, the State/UT would be required to submit a proposal, with supporting documents indicating fund transfer to SNA by the State/UT.

- After completion of IAY houses, States/UTs will submit proposal to the Ministry for reimbursement of the Central Share spent by them on completion of incomplete IAY houses.
- No payment to IAY beneficiaries shall be made other than FTOs generated through AwaasSoft.
