Subject: Completion of pending Indira Awaas Yojana (IAY) houses and closure of the scheme-Reg.

Sir/Madam

I am directed to refer to the subject mentioned above and to say that the erstwhile rural housing scheme Indira Awaas Yojana (IAY) has been restructured into Pradhan Mantri Awaas Yojana-Gramin (PMAY-G) from 1st April, 2016. Accordingly, it is important that IAY accounts are settled and it is brought to a closure. A letter of even no. dated 22.01.2018 was also sent in this regard requesting that the IAY houses may be completed by 31st March, 2018.

2. It is proposed to hold a meeting under the chairmanship of Secretary, Rural Development, Government of India in the third week of June, 2018 to discuss and decide about settlement of IAY and closure of the scheme. To have a fruitful discussion it is important that information on IAY on the points shown in Annexure may be sent to the Ministry by 5th of June, 2018.
