Subject: Regional Workshops under Pradhan Mantri Awaas Yojana- Gramin (PMAY-G)-reg.

Sir/Madam,

Para no. 3.3 of the Framework for Implementation (FFI) of the PMAY-G provides for training of officials and demonstration of innovative technologies & works related to housing. Therefore, workshops with the States/UT's shall be conducted on a regular basis to monitor the progress of implementation of PMAY-G as well as to foster sharing of best practices amongst the States/ UT's.


2. Accordingly, this Ministry is contemplating conduct of Regional workshops on experience sharing among the States / UTs and avail this opportunity for review of the Scheme. This gains significance in view of the Phase-II of PMAY-G II which has just started. A tentative schedule of such workshops is **annexed**. To give ample time for exchange of experiences and field visits, it is suggested that these workshops may be conducted for 2 days. It is also stated that the States shall be reimbursed the cost of organizing such workshops after submission of duly verified bills and Vouchers by the State.

3. The State/UTs may depute around five Officials (both of state and sub-state levels) to represent their State / UT in the workshop and communicate their names to the organizing State for making necessary arrangements. Officials participating in the workshop may be advised to share their experiences, with respect to challenges faced and how they tackled it, requirement of policy interventions, if any, etc.

4. The States / UTs have been divided into various regions and also suggested the name of State / UT organising the workshop for each region and the same is annexed. The organizing State may indicate convenient venue and date for the workshop. The organizing State may make necessary arrangements for organisation of the workshop. It is also requested to submit a tentative cost for organisation of workshop in advance to enable this Ministry to release the funds to the organising State, if the same is not available with the State.
