Subject: - Meeting to review the implementation of PMAY-G on 27th July, 2018 at New Delhi – Request for participation - Reg.

Sir/ Madam,

I am directed to refer to the subject mentioned above and to say that the 1st phase of PMAY-G is in the final stages of implementation wherein it has been decided to construct 1.00 crore houses by December, 2018. In order to ensure that the set target is achieved within the stipulated time limit, a review meeting on implementation of different aspects of the scheme of PMAY-G will be held on 27th July, 2018 under the Chairmanship of Joint Secretary (Rural Housing), Ministry of Rural Development.

2. The proposed brief agenda for the meeting is as follows :-
- a) Landless beneficiaries and status of providing land to them.
 - b) Action plan for month-wise completion of targets, assigned under PMAY-G, by December, 2018.
 - c) Status of progress of identification of additional beneficiaries and uploading on AwaasSoft using Awaas+ and likely number of additional beneficiaries
 - d) Interchanging of targets among different categories / surrender of targets vis-à-vis the Permanent WaitList, if any.
 - e) Status of setting up of PMUs at different levels of administration (State / District / Block).

- f) Status of saturation of SAGY Gram Panchayats, Rurban clusters, Open Defecation Free GPs, GPs with strong social capital through DAY-NRLM SHGs, Gram Swaraj Abhiyan (14th April, 2018 to 5th May, 2018) villages, Extended Gram Swaraj Abhiyan (1st June, 2018 to 15th August, 2018) villages, Mission Antyodaya villages, Aspirational Districts.
- g) Status of convergence with MGNREGA for 90/95 days unskilled wages, toilet under MGNREGA / SBM-G and Pradhan Mantri Ujjawala Yojana (PMUY). Any other convergences facilitated by the State Government.
- h) IEC activities undertaken and the action plan proposed on IEC activities to achieve the target of PMAY-G by 2018-19.
- i) Feedback on the quality mobile App developed for monitoring the quality of houses constructed and making it functional from 15th August, 2018.
- j) Action Plan for implementation of Rural Mason Training, especially in those States where it is yet to start.
- k) Action plan to complete those houses where houses were not completed even after 12 months from the date of release of 1st instalment. Further, action plan for cases where houses have not been completed between 9 – 12 months from the release of 1st instalment.
- l) Status of construction of demonstration houses as per identified house design typologies.

3. The 27th July, 2018 meeting will be held at Hall No. 4, Vigyan Bhawan, New Delhi from 0930 Hrs till evening. The detailed agenda of the meeting communicating the information that the States / UTs are required to send to the Ministry by 25th July, 2018 would be communicated shortly. This meeting is in addition to the meeting scheduled on 26th July, 2018.
