
Sir/Madam,

**Issues to be covered in the presentation to be made before the EC to appraise the Annual Action Plan for FY 2017-18 under Pradhan Mantri Awaas Yojana- Gramin (PMAY-G)**

**I) PMAY-G- Performance of the Programme till 15<sup>th</sup> February, 2017**

- 1) Completion of mapping of SECC villages to PMAY-G GPs in AwaasSoft.
- 2) Finalisation of permanent waitlists (PWL) after due verification by Gram Sabha and through the Appellate process and entering the same on AwaasSoft.
- 3) Provision of land for landless beneficiaries- No. of landless households identified and action taken to provide them land.
- 4) Finalisation of category wise targets for FY 2016-17
- 5) Change/Surrender of targets or reallocation within categories in view of unavailability of beneficiaries.
- 6) Status and time line for registration, geo tagging and sanctions to the beneficiaries.
- 7) Plan and status of saturation of Gram Panchayats identified under Sansad Adarsh Gram Yojana Phase-I and Phase-II, covering GPs belonging to Rurban Clusters or have achieved Open Defecation Free (ODF) status or have a strong network of SHGs under the DAY-NRLM with respect to approved annual action plan.
- 8) Status, release of matching state share for FY 2016-17. Reasons for delay or shortfall, if any.
- 9) Status of utilization of central funds released under PMAY-G. Expected timeline for sending proposal for second installment.
- 10) Status of setting up of Project Management Units (PMUs) at various levels.
- 11) Number of rural masons trained, assessed and certified as per QP developed by the Ministry.
- 12) Conduct of ToT for orientation of master trainers and status of pilot initiative.
- 13) Engagement of accredited Training Provider (TP) to impart mason training.
- 14) Preparation of plan for upscaling of Mason Training Programme.
- 15) Finalisation of house design typologies, incorporation into Bill of Quantity and Schedule of Rates and construction of demonstration houses as per approved typology.
- 16) Conduct of Awaas Diwas and orientation/sensitization of beneficiaries/other stakeholders.

- 17) Seeding of beneficiary database and mapping of bank account details with Aadhaar Unique ID.
- 18) Action taken by the State for facilitating loans to willing beneficiaries.
- 19) Verification of financial reports (B3 and B4) available on AwaasSoft. State/UTs to verify opening balance as on 01.04.2016, miscellaneous receipts, State share and central releases reflected in the report.

- 1) Roadmap for completion of pending IAY houses by 31<sup>st</sup> March, 2017.
- 2) Furnishing proposals for pending liabilities under IAY, if any.
- 3) Furnishing certificate of deposition of all IAY scheme funds into State Nodal Account.

- 1) Demand projection for houses in FY 2017-18 and timeline proposed for various actions from registration/sanction to completion.
- 2) Submission of proposals for facilitating procurement of material by beneficiaries under PMAY-G for its smooth implementation.
- 3) Engagement of reputed technical institutes as State Technical Support Agency (STSA).
- 4) Plan of local production of construction material under MGNREGA through SHGs etc.


