

Dear Colleague,

As you are aware, to achieve the goal of "Housing for All by 2022", Pradhan Mantri Awaas Yojana – Gramin (PMAY-G) came into being from 1st April, 2016 with a target of completion of 2.95 crore rural houses. In the first phase of PMAY-G (i.e. 2016-17 to 2018-19), target of construction of 1 Crore houses was kept. I would like to appreciate the efforts of all State/UT for their contribution towards completion of targeted PMAY-G houses.


2. The Union Cabinet has approved the Phase-II of PMAY-G (2019-20 to 2021-2022) and target of construction of 60 lakh PMAY-G houses has been kept for the year 2019-20. PMAY-G Phase-II has commenced from 1st April 2019.

3. It is quite possible that during the implementation of PMAY-G (Phase-I) you might have faced problems/difficulties which might require amendments in the Framework for Implementation of PMAY-G.

4. Accordingly, I would like to invite your suggestions/inputs for revision/amendment etc. in the Framework for Implementation of PMAY-G by 22nd April, 2019 to enable this Ministry to incorporate necessary changes. The draft then would be circulated to/discussed with the States. You are also requested to look into AwaasSoft/AwaasApp and then suggest new features, amendments etc. in them.
