

Points to be included in the write up and power point presentation to be made before the Empowered Committee of Government of India by the State / UT Secretary / Principal Secretary / Additional Chief Secretary

Physical, Financial progress:-

1. State profile with special reference to houselessness, category-wise population, total housing requirement and targets for 2016-17 to 2018-19 and 2019-20 to 2021-22, SECC data etc.
2. Status of verification of SECC list by the Gram Sabhas, preparation of category-wise permanent wait list and then its upload on AwaasSoft.
3. District-wise and category-wise targets for the year 2016-17 after full survey and need.
4. Proposal, if any, for surrender / change in targets
5. Plan to make available land to landless beneficiaries and how to cover homeless households, automatically included households, those living under polythene sheets selected.
6. Plan for saturation of SAGY villages of both Phase-I and Phase-II, Open Defecation Free (ODF) villages, villages under Rurban cluster, villages with strong network of women self-help groups under DAY-NRLM or any other saturation approach adopted by the State / UT.
7. Status of opening of single State Nodal Account, opening balance as on 1.4.2016 and freezing of OB.
8. Status of unspent balances at the beginning of year, releases during 2016-17 and utilization of funds as on 10th August, 2016.
9. Projection of quarter-wise requirement of funds including committed liabilities (to be shown separately for IAY and PMAY-G)

11. Plan for orientation of beneficiary.
12. Progress in Mason Training and plan with timelines, including identification of training providers, number of trainees etc.

14. Plan to ensure 90/95 days of labour through MGRNREGS for construction of houses.
15. Plan for convergence with SBM etc. for construction of toilets
16. Proposed action for disbursement / facilitation of loan to willing beneficiaries.
17. Plan, with timelines, on use of locally available material
18. Confirmation for availability of State Share of funds.
19. Seeding of Aadhar number in beneficiary bank account.
