Subject: Meeting with State Nodal Banks and officials of PFMS to  
resolve the issues relating to direct transfer of assistance to the  
beneficiaries of Pradhan Mantri Awaas Yojana – Gramin  
(PMAY-G) – Reg.

Sir,

As you are aware that, in order to ensure transparency and timely  
payment of assistance to the beneficiaries of PMAY-G, it is mandated  
that the assistance be paid directly into the savings bank accounts of the  
beneficiaries from the State Nodal Bank Account through AwaasSoft-  
PFMS Platform.

2. However, in the process of transfer of assistance to the  
beneficiary bank accounts, issues relating to bank account verification,  
transfer of funds, reporting of cases of false success and false failure etc.,  
are cropping up, which are eventually delaying the transfer of assistance  
and thus defeating the purpose itself. These issues have been discussed  
with PFMS team at Delhi during various interactions and it was decided  
that the State Nodal Banks also need to play significantly important role  
to resolve the issues at the earliest. Accordingly, a meeting with the State  
Nodal Banks is proposed to be held on 20th December, 2016 in  
“Unnati” Conference Hall, Krishi Bhawan, New Delhi at 10:00 Hrs.

3. In this regards, the State Govts would also want to highlight the problem faced by them, as such it requested to nominate officials dealing with the subject to participate in the meeting. The issues that would be discussed during the meeting are as follows :-

- a) Restricting debit from the State Nodal Account only through Fund Transfer Order from AwasSoft.
- b) Sending SMS to the beneficiaries registered mobile number on receipt / transfer of assistance in their bank account.
- c) Resolving cases of pending bank account validation.
- d) Resolving cases of pending Fund Transfer Order payment.
- e) Settlement of False Success and False Reject cases.
