Sir,

I am directed to convey the administrative approval of the Government of India to incur an expenditure not exceeding **Rs.30,33,000/- (Rupees Thirty Lakh Thirty Three Thousand only)** to the State of Madhya Pradesh as **1st installment** towards Central Assistance of Special Project (Rehabilitation) **for the year 2017-18** for implementation of the Pradhan Mantri Awaas Yojana - Gramin (PMAY-G) in the Zila Panchayat Betul of Madhya Pradesh as per the following details:

2. I am directed to convey the sanction of the President of India to the lumpsum payment of Rs.30,33,000/- (Rupees Thirty Lakh Thirty Three Thousand only) to the Agency "Panchayat & Rural Development Department", which is the state nodal agency for implementation of PMAY-G in the State of Madhya Pradesh.

3. The grant is towards the Revenue Expenditure and shall be utilised for construction of new houses subject to the conditions laid down in the framework for implementation under the Pradhan Mantri Awaas Yojana-Gramin and extant instructions issued from time to time. No deviation from the provisions of the Framework for Implementation of PMAY-G is permissible.

4. The sanction will be subject to the following conditions:-

- a) The expenditure on the implementation of the programme will be shared in the ratio of 60:40 between the Centre and State.

- b) It is reiterated that while allocating targets to Districts, State should follow the formula prescribed by the Ministry. It is clarified that earmarked targets for SC, ST and Minority cannot be diverted to General Category. Only SC and ST targets can be interchanged if there are sufficient justifications.
- c) The state share should also be released within 15 days from the date of release of the Central share. In case of shortfall in State share, corresponding amount of Central share will be deducted from the 2nd installment. The factum of release of these funds must be registered in the Public Financial Management System (PFMS). The State Government is also requested to invariably endorse the copies of the release orders to the Central Government addressed as under:

- d) The accounts of all grantee institutions or organizations shall be open to Audit both by the Comptroller and Auditor General of India as well as by the Internal Audit Wing of the Principal Accounts Officer of the Ministry of Rural Development/Department functioning under the Chief Controller of Accounts, in terms of Rule 236 of General Financial Rules, 2017.

5. No Utilisation Certificate is pending in respect of Pradhan Mantri Awaas Yojana - Gramin against the recipient organisation for the previous year. Utilisation Certificate of Indira Awaas Yojana prior to financial year 2016-17 must be submitted by the State separately.
